## **Paycheck Protection Program Guidance**

On Sunday, April 26 the Treasury Department issued a new FAQ document regarding the Paycheck Protection Program which opened to taking applications this morning at 9:30 am local time. You can read the FAQ <a href="here">here</a>. According to some <a href="reports">reports</a>, there have been some technical glitches today as banks raced to upload pooled applications that were not accepted in the first round and had been completed between that round and today. Still, Treasury reports that it processed over 100,000 loans from 4,000 lenders today. The Consumer Bankers Association is <a href="predicting">predicting</a> that the second round window (\$310 billion) might run out of funds and close before the end of the week.
