COVID-19 Update: June 11, 2021

Phase 5 Starts Today - Friday, June 11: Guidance for Businesses and Venues:

This guidance replaces the industry-specific guidance that the Department of Commerce and Economic Opportunity published as part of the state's Restore Illinois plan. This guidance includes recommendations for all types of businesses and venues, customers, and employees in order to help maintain healthy environments and operations, as well as lower the risk of COVID-19 spread.

The following are recommended prevention strategies that recognize that while the state of Illinois has made substantial progress in vaccinating its residents, a number of individuals remain ineligible or have not yet chosen to be vaccinated. Consistent use of prevention strategies will help reduce the spread of COVID-19 and protect people who are not fully vaccinated, including customers, employees, and their families. As always, businesses and local municipalities may choose to implement additional prevention strategies as they deem appropriate.

- COVID-19 vaccines are safe, effective, and widely available across Illinois. Everyone aged 12
 years and older should be <u>vaccinated</u> against COVID-19 as soon as possible to keep from getting
 and/or spreading COVID-19.
- For businesses and venues where everyone present is <u>fully vaccinated</u>, the state does not require face coverings and social distancing in both indoor and outdoor settings. Businesses and municipalities are permitted to continue requiring face coverings and social distancing as they deem appropriate.
- For indoor businesses and venues where everyone present is not <u>fully vaccinated</u>, unvaccinated persons should wear a face covering and maintain six feet social distance. Businesses and venues may continue to require face coverings and/or social distancing. At outdoor businesses and venues, unvaccinated persons may choose not to wear a face covering when able to maintain a six-foot social distance while outdoors, unless required to do so by a business or municipality.
- Although people who are fully vaccinated are not required to wear a face covering under state
 guidance, businesses and venues should be supportive of customers and employees who choose
 to wear a face covering.
- Persons who are immunocompromised should consider wearing face coverings when in settings where others may not be fully vaccinated.
- All unvaccinated persons should wear face coverings in crowded settings, both indoors and outdoors, especially when youth are present. See CDC guidance for further information.

- There are limited circumstances and settings where all individuals, including those who are fully vaccinated, must continue to wear a mask in accordance with <u>CDC guidance</u>: (1) on public transportation, (2) in congregate facilities, (3) in health care settings, and where required by federal, state, local, tribal, or territorial laws, rules, and regulations, including local business and workplace guidance.
- Individuals in schools, day care settings, and educational institutions should continue to follow separate guidance issued by the Illinois State Board of Education, Illinois Department of Children and Family Services, and Illinois Department of Public Health.
- All businesses and venues should support social distancing to the extent possible, especially in indoor settings. Businesses and venues should apply best practices in managing distancing at such places as concessions/counters, public restrooms, and lines/queuing.
- This guidance will be updated as the CDC releases new recommendations and is meant to supplement any federal or local guidance, safety laws, rules, regulations or business safety policies that may expressly require a face covering and/or social distancing.
- Continue to consult the <u>CDC</u> and <u>IDPH</u> websites for updated resources, guidelines, and rules related to COVID-19 safety.

According to the Illinois Department of Public Health, all of Illinois will enter "Phase 5" of the Restore Illinois plan. In Phase 5, nearly all restrictions on commerce, such as occupancy limits in restaurants, are lifted. Businesses, schools, and recreation can resume normal operations with new safety guidelines and procedures. Conventions, festivals, and large events may take place. Fully vaccinated people can resume activities without wearing a mask except where required by federal, state, local, tribal, or territorial laws, rules and regulations, including local business and workplace guidance. Regardless of vaccination status, masks will still be required on planes, buses, trains, and other forms of public transportation; in transportation hubs, such as airports and train and bus stations; in congregate facilities such as correctional facilities, veterans' homes, and long-term care facilities, group homes, and residential facilities; and in healthcare settings. Restaurant Revitalization Fund Replenishment Act to be Introduced

The \$28.6 billion Restaurant Revitalization Fund (RRF) was established by the American Rescue Plan to help bars and restaurants recover from lost revenue in 2020. The program was incredibly popular and ran out of money within weeks of opening in early May. The SBA estimates that they need at least an additional \$50 billion just to fund the applications submitted before the application portal was closed. On Thursday, June 10 a bi-partisan group of senators and representatives will introduce the RRF Replenishment Act to direct an additional \$60 billion to the SBA to continue the program. More

Wide vaccination adoption is the best way to ensure our economy can fully reopen. As of May 18, only about 42% (depending on county) of the citizens in Greater Peoria have been fully vaccinated. Tazewell County Health Department is scheduling appointments at their Broadway Clinic (Pekin) Monday through Friday 8:30 am - 6 pm as well as at their Tremont facility Monday through Friday from 9 am - 4:30 pm. They are also hosting a drive-thru clinic on June 10 at the Tazewell County Health Department in Tremont from 9 am to 4:30 pm (no appointment necessary). The Woodford County Health Department is scheduling appointments for three upcoming Johnson & Johnson clinics:
